#### Partners in (Repairing the harm of) Crime

WCCC, Inc. conducted a Tubman Advocate Circle Training on Friday afternoon, April 8 lead by Circle trainers Gary Schurrer, Lynn Schurrer, Katie Schurrer and Bob Storlie. Nine participants attended and were asked to provide an evaluation of the event, including Tubman legal advocates and CEO Jennifer Polzin.



Training participants were asked to rate the training as well as leave anecdotal feedback on the value of the training. The training received an average of 4.7 out of 5. Participants stated that they felt more comfortable with the how Circles operate after the training and that it brought a better understanding of the process of making referrals to Circle and what cases might be good Circle cases. In fact, when asked to note what they felt was least valuable one noted that it was "all very valuable" and had no "least valuable" components of the training.

We would like to thank the Tubman participants for their time and feedback, and we are pleased Tubman found the training informative and engaging!

# **Circle Training May 20-21**


